- Review Committee has been established (3 private sector board members – 2 WIOA partner organizations)
- RFP was due on February 25<sup>th</sup>
  - 4 Proposals were received, all proposals met the 'minimum requirements'
- Recommendations to NSWB Executive Committee midto late April
- Recommendation to Board and vote May 13<sup>th</sup>
- New contract in place July 1, 2021


Program provides assistance to unemployed MA residents who are struggling with job search activities due to a lack of technology. Customers must agree to work with MassHire to find employment and/or training


